PRE-FILED WRITTEN TESTIMONY OF PETER SANNIZZARO

My name is Peter Sannizzaro, and I am President and Chief Executive Officer of Talcott Resolution Life, Inc. (“Talcott”).

The insurance companies that are the subject of this hearing, Talcott Resolution Life Insurance Company, Talcott Resolution Life and Annuity Insurance Company, American Maturity Life Insurance Company, and Talcott Resolution International Life Reassurance Corporation (collectively, the “Domestic Insurers”), are indirect wholly owned subsidiaries of Talcott.
